Pain Management -Anatomy, Conditions and Coding Concerns

□ If the encounter is for pain control or pain management, assign the code from category G89 followed by the code identifying the specific site of pain. □ If the encounter is for any other reason except pain control or pain management, and a related definitive diagnosis has not been established by the provider, assign the code for the specific site of pain first, followed by the appropriate code from category G89.

Pain Quick Reference for ICD-10-CM - AAPC

If the pain is not specified as acute or chronic, do not assign codes from category 338, except for post-thoracotomy pain, postoperative pain, or neoplasm-related pain. For example a patient with chronic abdominal pain would be coded to 789.00 and 338.29, while a patient with abdominal pain would be coded to 789.00.

Coding Pain Management Services

The ICD-10-CM Official Guidelines for Coding and Reporting provide extensive notes and instruction for coding pain (category G89). Review these guidelines in full. The following summary identifies key points. When seeking a pain diagnosis, identify as precisely as possible the pain's location and/or source. If pain is the primary symptom and you know the location, the Alphabetic Index generally will provide all the information you need.

Coders should determine whether the documentation supports an Evaluation and Management (E&M) service, including the chief complaint (related to postoperative pain) and at least two of the three required elements for subsequent hospital care (History, Examination, and Medical Decision Making).
